Turabian style bibliography format

If you mention your sources in your thesis or thesis (or category document) using numbered notes, you should probably also include a bibliography. A bibliography is an alphabetical list (per author) of all the sources mentioned in the notes. Place the bibliography at the end of the document. If you use endnotes instead of footnotes, the bibliography will follow the endnotes. Here's how to form a bibliography for a Chicago-style paper that follows instructions in Kate L. Turabian's Handbook for authors of research papers, theses, and theses. Center the Bibliography title at the top of the first page. Add two blank lines between the title and the first entry. Entries are displayed with the cleanup left, leave the right margin ragged. Apply a half-inch first-line outdent for each entry. Single dotted each entry and add a blank line between entries. For multiple projects by the same author(s), replace the names with a 3-em dash in all entries after the first. To see what this looks like, consult the sample page below. Comments In a note, enter the author's full name, starting with the author's name (e.g. Carol Shields). In bibliography, mention the author's name starting with the author's last name (e.g. Shields, Shields). The publisher's name may be slightly abbreviated by omitting it, Inc., Ltd., Co., etc. If a project contains more than one publishing items, include only the first location in the list. If the place of publication is not known or could be confused with another place with the same name (e.g. Cambridge), then add the abbreviation province or state in two-letter postcode format without periods separating the letters (e.g. Cambridge, MA) (14.129, 10.28). Comments In the bibliography, if two authors are listed, reverse the name of the first author and add a comma with it and proceed to the name of the second author. Spell and in letters - do not use a commercial and & between the first and second names of the authors. If the project listed is a version other than the first, include the version number after the title (14.114). Comments For books with more than three and fewer than ten authors, all names should be fully mentioned in the literature. In a note, only the name of the first author must be fully mentioned. Other names can be replaced by et al. See example above. For works with more than ten authors, only the first seven must be fully mentioned in the literature; The remaining names can be replaced by et al. Comments An organization as a writer can be an organization, association, company, committee, city, etc. there is a personal author name on the title page. Give the organization as editor in the literature, even if the organization is also the publisher. Comments When books have authors, translators, or compilers, the following abbreviations are used: an author - ed. / two or more authors - eds. (10.42) translators - trans. (14.72) a compiler - comp. / two or more compilers - comps. (14.84) For book editions other than the first, the publication number (or description) and the abbreviation 'ed.' are placed after the title of the book in all notes and bibliographical references (14.103 - 14.105). For example: If there is no author on the title page of a project, list the names of the editor (edited editor or eds.), compiler (comp. or comps.), or translator (trans.). Comments Online and online books follow the same format as printed books with some additional information at the end of the referral. If you downloaded an e-book, add the media type at the end of the report (e.g. Kindle version, PDF ebook, CD-ROM). (14.161-14.162) If you consult a book online or through a database (e.g. Ebook Central, Google Books, Wiley), add the DOI (Digital Object ID) where available at the end using the format: :xxxx. If there is no doi, include the URL. (14.161) If there are no page numbers, include a section title or chapter or other number in place of page names (e.g. chap. 10). (14.160) You are not required to include the date of access, but you can include one if you prefer your discipline. Include it after the year of publication in the following format: Access on 1 January 2017. (14.12). Continue with the title of the chapter in quotation marks, followed by (in a note) or in (in the bibliography), followed by the title of the entire book and the author or authors. Two authors in the notes: After the edited book title, type in: eds. followed by names (e.g. eds. Anne Carr and Mary Stewart). Two authors in the literature: After the edited title of the book, type: edited by Anne Carr and Mary Stewart. Stewart.
